APPG on Hospice and End of Life Care Annual Activity Report- 2023/2024

Overview by the APPG Co-Chairs

Over the last year, we have been pleased to see the parliamentary attention paid to the importance of hospice services, the support they provide to those at the end of their lives and their role in the health and care system.

In June, a Westminster Hall Debate was held on to discuss support for hospice service, which saw MPs, including members of this APPG, highlighting the work of their local hospice and the services funding needs. As co-chair of the APPG on Hospice and End of Life Care, Peter Gibson MP raised the work of the APPG in the year before highlighting the need for sustainable funding following the pandemic, as well as the national deficit hospices facing hospices due to rising costs and flat funding.

This year funding has been a particular concern for hospices. As for everyone, increases in the cost of living have meant that hospices are struggling to keep up with rising energy and staffing costs. At the same time the local communities that give so generously found they were less able to do so. Hospice UK found in Spring 2023 that 96% of hospices were budgeting for a deficit in the year 2023/24. Hospice have had to make difficult decisions about the future of their services, which so many rely on, and which play a vital role in the health and care system.

Hospice also shared concerns with APPG members that the government funding they were receiving was often unequal, confusing and not reflective of the services they deliver. Hearing these concerns from hospices, this year the APPG has focused on the commissioning of hospice services. In July 2023, the APPG launched an inquiry into hospice funding. The APPG held two parliamentary oral evidence sessions as part of this inquiry, amplifying the experiences of those in the sector, and received over 80 pieces of written evidence.

The inquiry report found that despite the introduction in the 2022 Health an Care Act of a legal requirement for Integrated Care Boards (ICBs) to commission palliative and end of life care, ICB commissioning of hospice services is currently not fit for purpose. The report found significant variation in the funding provided to each hospice, and found a £47 million real terms cut in government funding for hospices. As a result, the services hospices provide for dying people and their families, and the value they provide to the wider health and care system, is at risk.

The need for palliative care is projected to increase by 25% by 2048. The contribution of hospices is both vital to meeting this need and ensuring that the NHS and social care have the capacity to prevent and treat disease. The APPG hopes that this report will support both national Government and ICBs to make the necessary reforms to fully realise the benefits of the hospice sector. Looking ahead, the APPG will continue to raise the need for reliable government support for the hospice sector, and advocate for the most beneficial relationship between charitable hospices and the NHS.

Publications

January 2024 – Government funding for Hospices.




